ORDER

In exercise of the powers vested under Section 14 (3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Northern Regional Committee grants recognition to **Kali Prasad LT Training College, Allahabad, 12/4, Kamla Nehru Road, Allahabad, (U.P.)** for **B.Ed. of One year** from the academic session **2000-2001** with an annual intake of **80 (Eighty)** students, subject to fulfilling the following conditions:

1. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
2. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
3. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University/State Government.
4. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University/State Government till such time NCTE regulations in respect of fee structure come into force.
5. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University/Examining body.
6. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
7. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance

काली प्रसाद प्रशिक्षण महाविद्यालय, इलाहाबाद, यूपी को एल.टी. पाठ्यक्रम की 40 सीटों की अनुमति सत्र 98-99 के लिए समिति कार्यालय द्वारा प्रदान की गई थी। अब उत्तर प्रदेश राज्य सरकार ने पत्र क्रमांक कि.प्र.म.वि./522/99-2000 दिनांक 27.09.99 के द्वारा एलटी पाठ्यक्रम को बंद कर उसके स्थान पर बीएड पाठ्यक्रम खोलने की अनुमति प्रदान की है तथा संस्था से प्राप्त पत्र दिनांक 4.10.99 के अनुसार अब संस्था में 8 अध्यापक हो गये हैं अतः इस संबंध में उत्तर क्षेत्रीय समिति की 20 वीं बैठक में राज्य सरकार के उक्त आदेश के संदर्भ में लिए गए निर्णय के परिप्रेक्ष्य में काली प्रसाद प्रशिक्षण महाविद्यालय, इलाहाबाद, यूपी को एलटी पाठ्यक्रम के स्थान पर सत्र 99-2000 के लिए बीएड पाठ्यक्रम 80 सीटों के साथ चलाने की अनुमति प्रदान की जाती है। संस्था राज्य सरकार के एलटी पाठ्यक्रम बंद करने के आदेश में वर्णित औपचारिकताओं की पूर्ति करेगी एवं परिषद् द्वारा बाएड पाठ्यक्रम की मान्यता हेतु निर्धारित मानदंडों का पूर्णतः पालन करेगी। यदि संस्था मानदंडों का पालन नहीं करती है तो संस्था के विरुद्ध परिषद् अधिनियम एवं इनके अन्तर्गत जारी विनियमों के अन्तर्गत कार्यवाही की जा सकती है।

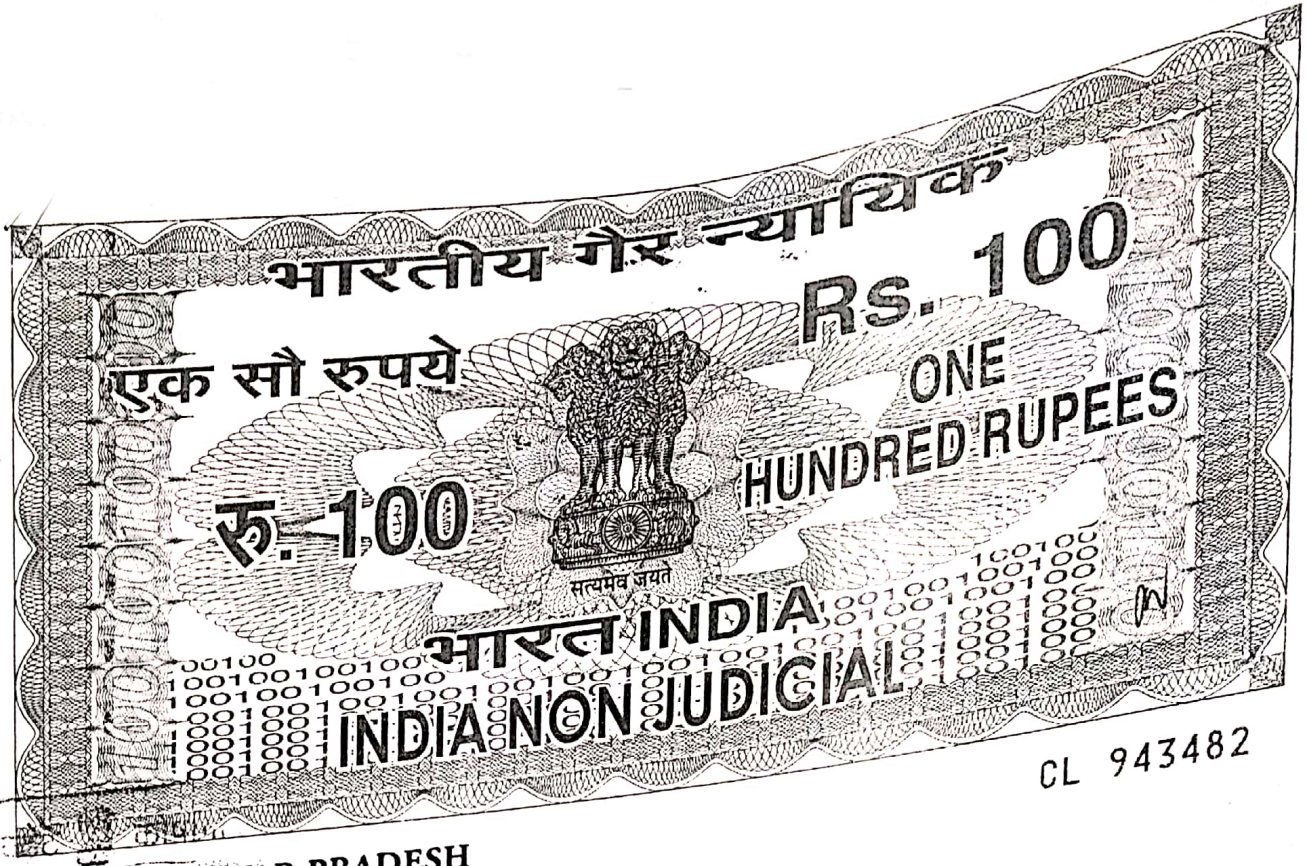

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution **Kali Prasad LT Training College, 12/4, Kamla Nehru Road, Allahabad, Uttar Pradesh** has by affidavit consented to come under New Regulations and has sought for one basic units in B.Ed.

3. Now therefore, in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Northern Regional Committee, NCTE hereby grants recognition to **Kali Prasad LT Training College, 12/4, Kamla Nehru Road, Allahabad, Uttar Pradesh** for conducting B.Ed. programme of two years duration with an annual intake of 50 for one basic units of 50 students from the academic session 2015-2016.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- Sanctioned programmes along with annual intake in the institution.
- Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- Name of faculty members who left or joined during the last quarter.
- Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- Fee charged from students.
- Available infrastructural facilities.
- Facilities added during the last quarter.
- Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if is so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action



including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
